Beneficiary Advisory Councils (BACs) are a recent (2024) requirement under the CMS Access Rule, designed to give Medicaid members a formal role in shaping state policies. They center Medicaid members in policy and program design.

When properly implemented, BACs surface insights that states may otherwise miss. The result? More effective and responsive Medicaid programs.

States don't merely want to *launch* BACs: They want to be sure they are effective, and that members can provide meaningful insights. But that can be a heavy lift for already-overwhelmed programs.

Kentucky's DMS partnered with Altarum to ensure their BAC members not only attend BAC meetings but are meaningfully engaged and receive the guidance they need:


